The right person for the job will ideally have experience in a busy environment and hold at least a level 3 CCLD or equivalent as well as a valid paediatric first aid certificate. The ideal candidate will be able to inspire, support and guide our children in their development in fun and exciting ways.

Essential Qualities:

Caring and warm-natured.

A high level of multitasking is essential.

Patience and adaptability: if something would normally take 5 minutes to achieve, you must be comfortable with it taking 15 minutes or longer.

The ability to rapidly count the heads of numerous moving small people is of the utmost importance.

Must be able to laugh at jokes that you don't understand. Child humour can be a minefield to navigate.

You will preferably have an affinity with the ridiculous and a willingness to engage fully in make-believe.

Able to plan effectively for the day/week/month and then abandon all plans to follow children's interests.

You must feel comfortable telling everybody that you are going to use the bathroom.

A high level of comfort being asked personal questions by children is essential. You will regularly be asked what you are having for lunch, if you are willing to share said lunch, whether or not you are married, and if not, why not, where you are going (as you walk to the toilet), and what you did in there (the toilet), etc.

You must be able to remain focused in environments with high noise levels.

You must have the ability to read a ten-page fairy tale with at least one interruption per page.

You must be prepared to have a lot of fun in the workplace. Laughter is something you can expect to engage in for a large part of your working day.

In addition:

The ability to sing in tune is not necessary, however the ability to sing in front of a crowd is.

Pretending to eat playdough creations realistically - this skill may develop with time and experience.

The ability to remember the names of a number of children, their parents, siblings, grandparents, pets and special soft toys is a key component of this job. Again, this is something that will develop over time.

You must be able to communicate and write to a good standard in English but willing to learn key words in other languages that the children may speak such as French, Italian, Lithuanian and (essentially) Nonsense and Gibberish

Finally, you must be prepared to feel loved, special, and important to many young children and their families. **There is simply no other job quite like this one.**
